#### **Description of Network Change:**

Frontier Telephone of Rochester, Inc ("Frontier") announces that it intends to retire copper facilities serving in the following wire center located in the state of New York:

The specific serving locations are listed on [Attachment A](#). Due to a planned City of Rochester, NY road department project to reconstruct and realign East Main Street, Frontier Telephone of Rochester, Inc is required to remove and relocate its facilities and equipment located within the road project. Frontier plans to construct a FTTP fiber network infrastructure to serve all existing and future customers. Existing customers on copper facilities will be migrated to the new fiber network infrastructure without incident.

#### **Description of Reasonably Foreseeable Impact of the Planned Changes:**

For the locations reflected in [Attachment A](#), Frontier will (1) no longer offer services over copper facilities; and (2) cease maintaining the copper facilities. There are presently 299 total working services none of which are competitive carrier circuits.

Customers will not be affected by changes in prices, terms, or conditions.
