Description of Network Changes Planned:

Frontier Comm of NY announces that it intends to retire its Stromberg Carlson DCO switch for the wire centers listed below:

On or after September 10, 2024, the St Johnsville, NY DCO switch, and associated remotes will be retired and removed from the Frontier network as part of ongoing efforts to modernize the network.

The Exchange Code (NXX) in Numbering Plan Area (NPA) 518 currently residing in the St Johnsville, NY DCO switch and associated remotes (see list in Table B below) will be moved to the GLVVNYXAPSO PEO virtual switch (see details in Table A below).



Description of Reasonably Foreseeable Impact of the Planned Changes:

The native NPA NXX belonging to the St Johnsville, NY DCO switch, and associated remotes will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Gloversville, NY PEO switch. This will occur on or after September 10, 2024.

Network Changes and Trunk Rearrangements:

The Gloversville, NY PEO switch will be the recipient office of traffic migrated from the St Johnsville, NY DCO switch and Associated remotes. Traffic bound for the codes listed in Table B will be delivered via the Gloversville, NY Tandem (GLVVNYXA01T Intra-Lata SHA/ GLVVNYXA01T Inter-Lata FG Access SHA).

After all traffic is migrated off the St Johnsville, NY DCO switch and remotes, it will be retired and removed from the network.



Description of Reasonably Foreseeable Impact of the Planned Changes (cont.):

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Gloversville, NY Tandem or have existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the St Johnsville, NY DCO switch, and remotes will be required to reposition the codes to the Gloversville, NY Tandem switch.

All ASRs (Access Service Requests) for the Gloversville, NY Tandem switch must be received no later than August 10, 2024, to provide sufficient time to migrate the traffic described above. All traffic must be moved by September 10, 2024. All ASRs for the Gloversville, NY Tandem switch must carry the project code of STJNNYXADS0.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the St Johnsville, NY DCO switch and remotes.
