Description of Network Changes Planned:

FRONTIER COMM OF TEXAS - announces that it intends to retire its GTD5 switch in the wire center listed below:

On or after October 7, 2024, the Garland Southeast, TX GTD5 switch, and associated remotes will be retired and removed from the Frontier network as part of ongoing efforts to modernize the network.

The Exchange Codes (NXX) in Numbering Plan Area (NPA) 972 currently residing in the Garland Southeast, TX GTD5 switch and associated remotes (see list in Table B below) will be moved to the IRNGTXXBPSO PEO virtual switch (see details in Table A below).



Description of Reasonably Foreseeable Impact of the Planned Changes:

The native NPA NXX belonging to the Garland Southeast, TX GTD5 switch, and associated remotes will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Irving, TX PEO switch. This will occur on or after October 7, 2024.

Network Changes and Trunk Rearrangements:

The Irving, TX PEO switch will be the recipient office of traffic migrated from the Garland Southeast, TX GTD5 switch and Associated remotes. Traffic bound for the codes listed in Table B will be delivered via the Irving, TX Tandem (IRNGTXXB01T Intra-Lata SHA/ IRNGTXXB01T Inter-Lata FG Access SHA).

After all traffic is migrated off the Garland Southeast, TX GTD5 switch and remotes, it will be retired and removed from the network.

Description of Reasonably Foreseeable Impact of the Planned Changes (cont.):

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Irving Tandem or have existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the Garland Southeast, TX GTD5 switch, and remotes will be required to reposition the codes to the Irving Tandem switch.

All ASRs (Access Service Requests) for the Irving Tandem switch must be received no later than September 7, 2024, to provide sufficient time to migrate the traffic described above. All traffic must be moved by September 30, 2024. All ASRs for the Irving Tandem switch must carry the project code of GRLDTXXEDSO.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Garland Southeast, TX GTD5 switch and remotes.
