On or after January 6, 2025, the Miller Grove, TX DMS-RLCM switch, and associated remotes will be retired and removed from the Frontier network as part of ongoing efforts to modernize the network.

The Exchange Codes (NXX) in Numbering Plan Area (NPA) 903 currently residing in the Miller Grove, TX DMS-RLCM switch and associated remotes (see list in Table B below) will be moved to the Cash, TX DMS-100 switch (see details in Table A below).

Description of Reasonably Foreseeable Impact of the Planned Changes:

The native NPA NXX belonging to the Miller Grove, TX DMS-RLCM switch and associated remotes will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Cash, TX DMS-100 switch. This will occur on or after January 6, 2025.

Network Changes and Trunk Rearrangements:

The Cash, TX DMS-100 switch will be the recipient office of traffic migrated from the Miller Grove, TX DMS-RLCM switch and Associated remotes. Traffic bound for the codes listed in Table B will be delivered via the Dallas, TX Tandem (DLLSTXTA05T Intra-Lata SHA/ DLLSTXRIO1T Inter-Lata FG Access SHA).

After all traffic is migrated off the Miller Grove, TX DMS-RLCM switch and remotes, it will be retired and removed from the network.

Description of Reasonably Foreseeable Impact of the Planned Changes (cont.):

CLECs, IXCs, IECs, wireless carriers, and paging carriers will need to secure new trunk groups built to the Dallas Tandem or have existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the Miller Grove, TX DMS-RLCM switch and remotes will be required to reposition the codes to the Dallas Tandem switch.

All ASRs (Access Service Requests) for the Dallas Tandem switch must be received no later than December 2, 2024, to provide sufficient time to migrate the traffic described above. All traffic must be moved by December 16, 2024. All ASRs for the Dallas Tandem switch must carry the project code of MLGRTXXARSO.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Miller Grove, TX DMS-RLCM switch and remotes.
