On or after April 1, 2025, the Snowshoe, WV DCO switch will be retired and removed from the Frontier network as part of ongoing efforts to modernize the network.

The Exchange Codes (NXX) in Numbering Plan Area (NPA) 304 currently residing in the SWSHWVXADSO DCO switch and associated remote (see list in Table B below) will be moved to the SWSHWVXARPO PEO virtual switch (see details in Table A below).

Description of Reasonably Foreseeable Impact of the Planned Changes:

The native NPA NXX belonging to the Snowshoe, WV DCO Host switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Charleston, WV PEO switch. This will occur on or after April 1, 2025.

Network Changes and Trunk Rearrangements:

The Charleston, WV PEO switch will be the recipient office of traffic migrated from the Snowshoe, WV DCO host switch. Traffic bound for the codes listed in Table B will be delivered via the Charleston, WV Tandem (CHTNWVLE26T) Intra-Lata SHA/ (CHTNWVLE26T) inter-Lata FG Access SHA).

After all traffic is migrated off the Snowshoe, WV DCO host switch, it will be retired and removed from the network.

Description of Reasonably Foreseeable Impact of the Planned Changes (cont.):

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Charleston, WV (CHTNWVLE26T) Tandem or have existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the Snowshoe, WV DCO switch will be required to reposition the codes to the CHTNWVLE26T Tandem switch.

All ASRs (Access Service Requests) for the Charleston (CHTNWVLE26T) Tandem switch must be received no later than February 1, 2025, to provide sufficient time to migrate the traffic described above. All traffic must be moved by March 1, 2025. All ASRs for the Charleston (CHTNWVLE26T) Tandem switch must carry the project code of SWSHWVXADSO.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Snowshoe, WV DCO switch.
